

**FBI BUILDINGS “FARM PROGRESS SHOW” SWEEPSTAKES
OFFICIAL RULES
NO ATTENDANCE NECESSARY TO ENTER OR WIN**

1. TWO WAYS TO ENTER:

- A. AT THE EVENT:** Come to the FBi Buildings (“Sponsor”) booth (Lot 167) at the Farm Progress Show in Decatur, IL from 8/26/25 – 8/28/2025 where you can enter the sweepstakes. You can visit the booth where you will have access to a computer and follow the directions to enter the sweepstakes. Entries must be received by 5:00 PM Central Standard Time (“CST”) on each day of the show.
- B. ONLINE:** Beginning 8:00 AM CST on 8/26/2025 through 5:00 PM CST on 8/28/2025 (“Promotion Period”), visit fbibuildings.com/register and follow the on-screen instructions to complete the entry form and submit an entry into the sweepstakes. Entries must be received by 5:00 PM CST on each day during the Promotion Period to be entered into the drawing. A person can use only one email address to enter. Administrator’s computer is the official time-keeping device for the sweepstakes. **Limit one (1) entry per person per day regardless of method of entry (at the event or online).**

- 2. ELIGIBILITY:** This promotion is open only to residents of the 48 contiguous United States and the District of Columbia, 18 years of age or older as of date of entry. Employees of FBi Buildings, its affiliates and/or subsidiaries, advertising, promotion, and internet agencies (collectively “Released Parties”) and their immediate family members and/or those living in the same household of each are not eligible. All federal, state, and local laws and regulations apply. Void in Alaska and Hawaii, and where prohibited by law.

RANDOM DRAWING:** A random drawing will be conducted on Friday, September 5th, 2025, to select one (1) winner from among all eligible entries received at the event and through the online methods of entry (the “Sweepstakes Winner”). A random drawing will be conducted by an agency designated by the Sponsor (“Judges”), whose decisions are final. Winner need not be present to win. Odds of winning will depend upon the number of eligible entries received by each entry deadline. Winner will be notified by telephone, mail and/or email.

- 4. PRIZE(S):** The Sweepstakes Winner of the 2025 Farm Progress Show Sweepstakes will have the option to choose between one of two distinct prizes: either the all-new Sharkfarmer Deer Blind or a discount of Fifteen Thousand Dollars and Zero Cents (\$15,000.00) off the purchase of a new FBi Buildings post-frame building.

- A.** If the Sweepstakes Winner selects the Sharkfarmer Deer Blind, the Winner shall be solely responsible for all costs associated with the delivery of the unit, whether delivered by FBi Buildings or a third-party delivery service. If the Customer chooses to hire a third-party delivery service, then FBi Buildings will load the Deer Blind into that carrier’s mode of transportation, and thereafter, the responsibility for delivery is solely the Winner’s. If the Winner chooses to have FBi Buildings deliver the Deer Blind to a mutually agreed-upon, accessible central location, the Deer Blind will be delivered to that location within a reasonable time, and the Winner will be responsible for providing all necessary equipment and labor to unload the unit. FBi Buildings shall not be liable for any delays, loss, or damage in transit. The Winner shall take delivery of the Deer Blind on the scheduled date of delivery.
- B.** If the Sweepstakes Winner selects the \$15,000.00 discount off a new FBi Buildings post-frame building, this prize is contingent upon on a new FBi Buildings pole barn purchase. To be eligible for this discount, the sales contract between the Winner and FBi Buildings must be signed by October 3rd, 2025. This discount cannot be applied to existing contracts or combined with any other offers, promotions, or discounts. This discount has no cash value and cannot be redeemed for cash.

The prize is non-transferable, and no substitutions will be made except as provided herein, at the sole discretion of FBi Buildings.
