

FBI BUILDINGS “FARM PROGRESS SHOW” SWEEPSTAKES

OFFICIAL RULES

NO ATTENDANCE NECESSARY TO ENTER OR WIN

1. TWO WAYS TO ENTER:

- A. AT THE EVENT:** Come to the FBI Buildings Inc. booth at the Farm Progress Show in Decatur, IL from 8/29/23 – 8/31/2023 where you can enter the sweepstakes. You can visit the booth where you will have access to a computer and follow the directions to enter the sweepstakes. Entries must be received by 5:00 pm Central Time (“CT”) on each day of the show.
- B. ONLINE:** Beginning **8:00 am CT** on 8/29/2023 through **5:00 pm CT** on 8/31/2023 (“Promotion Period”), visit fbibuildings.com/register and follow the on-screen instructions to complete the entry form and submit an entry into the sweepstakes. Entries must be received by **5:00 pm CT** on each day during the Promotion Period to be entered into the drawing. A person can use only one email address to enter. Administrator’s computer is the official time-keeping device for the sweepstakes.
- Limit one (1) entry per person per day regardless of method of entry.**

- 2. ELIGIBILITY:** This promotion is open only to residents of 48 contiguous United States and the District of Columbia, 18 years of age or older as of date of entry.
